2. An Expert Team conducted onsite evaluation of the programs from 14<sup>th</sup> to 16<sup>th</sup> October, 2022. The programs have been granted accreditation for 3 years. **Government Polytechnic Valsad, Kosamba Road, Valsad, Gujarat – 396001** should submit the Compliance Reports at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
